

# HIGH CEDARS LADIES CLUB

## Membership Meeting 1 March 2010

8 members (a quorum) were in attendance for the General Membership Meeting.

Annette Seydel opened the general membership meeting with a brief welcome.

New Business: The Club Championship Proposal was presented:

### PLAY

1. The championship is a scratch competition. ~~To encourage maximum participation and in the interest of fair play, the Club Championship will be played on Tuesdays and Saturdays over a three week period. The competition will begin on a Saturday and end on the Tuesday 17 days later giving six opportunities to play (3 Tuesdays and 3 Saturdays). The competition will be the best 2 out of 3 rounds. Participants in the tournament must specify prior to play, which three days out of the available six they will play in the competition.~~ To encourage maximum participation and in the interest of fair play, the Club Championship will be played two ( 2) days over a one week (7 day ) period. The days of play will be determined by a club ballot vote to be held by the fourth Tuesday in May. Following the results of the ballot vote, the Tournament Chairperson along with the Executive Board will set the dates for the Club Championship after consulting the course for availability. A sign up deadline will be established 2 weeks (14 days) prior to the date of the Club Championship Tournament, and qualifying rounds (Rules of Competition Sec I-Eligibility) must be met by that date. Handicaps will remain as they were on the first competition date of the Club Championship. The date will be listed on the approved schedule for the current year and forwarded to all members. The Executive Board must approve any change in the date of play.
2. In the event the stipulated rounds cannot be completed, the Executive Board shall determine the course of action to be taken.

### TIES

~~In the event of a tie for the championship, there shall be an 18-hole round play-off.~~ In the event of a tie for the championship, there shall be an 18-hole round play-off scheduled by the Tournament Chairperson and accompanied by an officer of the Executive Board.

Positive discussion ensued. The proposal was unanimously approved. The Club Championship will be held the week of August 14. Specific dates are to be determined.

Duffy Christy announced the Exchange Dates for Brookdale and Spanaway. Brookdale – Monday, June 14 and Spanaway – Thursday, July 15.

Gerene Lombardini gave the update for WSWPLA and the dates of play. These will be posted on the High Cedars Ladies Club website.

In Betty Jean O’Neal’s absence (sick), Annette made several announcements:

- The season will begin March 6.
- No call/No shows for play is unacceptable.
- If you do not sign up for play on Tuesday, you MUST call or talk to the pro shop to ensure you are on the list for play.
- Those who wish to play in the early slots must be at the club house 30 minutes early.
- On Medal Play days, golfers will be placed in foursomes according to handicap.
- Be conscious of the pace of play.

ECCE – There will be 2 ECCE seasons. Those who wish to participate must pay in advance.

Pat Bell gave an update on the Invitational Tournament. She asked that all be thinking now of donations that can be made for the raffle.

Sandy Brown gave the TWGA report. TWGA will be held at High Cedars on August 30.

Sandy also reported that WSGA requires that the Handicap Chairperson/Committee be handicap certified. Sandy Brown and Pat Bell volunteered to become certified.

Sandy Barnes (via telephone) volunteered to be the Team Play Chairperson. We are still looking for a volunteer for the Rules Committee.

Thursday Night Play – twice monthly the Championship Course will be played.
